

# 2018 Shelby County Builders Association Scholarship

The Shelby County Builders Association is pleased to offer a Five Hundred Dollar (\$500.00) scholarship to 4 graduating seniors from the five Shelby County Schools.

The criteria for the scholarship has been modified this year to focus more closely on the promotion of construction and other trades, and the students who intend to pursue careers in these fields.

Qualifying students who will be eligible for consideration must (a) intend to pursue a career in a trade and (b) not intend to attend a traditional four-year college or university. Candidates will be evaluated based upon their desired career, work experience, training for a career in the trades and letters of recommendation, as well as more traditional factors such as service to the community and extra-curricular activities.

Scholarship awards will be paid directly to institutions and organizations to defray the students' expenses in obtaining additional training. This includes, but is not limited to, two-year schools (such as Ivy Tech), as well as any other institution or organization that provides any training to students entering into the trades.

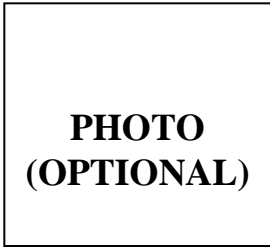
