A. Principals Reports

Mr. Chase informed board members that currently 31% of students passed the math 10 ISTEP testing. He explained that Mr. Gaking had created a spreadsheet to track a student's learning progress. When a student scores 75% or higher on an assessment, the spreadsheet will indicate that the student understands a certain standard. Mr. Chase further explained that once an assessment had been given by Mr. Meredith, the data was provided to Mr. Chase and Mrs. Chase who then entered the information into the spreadsheet. According to the spreadsheet data, around 50% of the students would now pass the testing. Mr. Chase provided board members a handout that showed how the assessments related to the standards.

Mr. Edwards explained how the elementary staff had been working to integrate the same color system and verbiage used in the Jr/Sr high school for students. This would help students and staff with continuity as they transition to the higher grades. Mr. Edwards stated that the elementary staff had been working to identify a student's academic needs and focus on areas that they had the ability to change. Mr. Edwards updated the board members on the progress of the new wrestling program.
