NOTICE OF EXECUTIVE SESSION

February 11, 2026

5:00 P.M.

Under Indiana Code 5-14-1.5-6.1, the Southwestern Consolidated School District of Shelby County Board of School Trustees will be conducting an Executive Session for the following reason(s).

- 1. Where authorized by federal or state statute.
- 2. For discussion of strategy with respect to any of the following:
 - (A) Collective bargaining.
 - (B) The initiation of litigation or litigation that is either pending or has been specifically threatened in writing.
 - (C) The implementation of security systems.
 - (D) The purchase or lease of real property by the governing body up to the time a contract or option to purchase or lease is executed by the parties.
 - (E) School consolidation.
- 3. For the discussion of the assessment, design, and implementation of school safety and security measures, plans, and systems.
- 4. Interviews and negotiations with industrial or commercial prospects or agents of industrial or commercial prospects by the Indiana economic development corporation, the office of tourism development, the Indiana finance authority, the ports of Indiana, an economic development commission, the Indiana state department of agriculture, a local economic development organization (as defined in IC 5-28-11-2(3)), or a governing body of a political subdivision.
- 5. To receive information about and interview prospective employees.
- 6. With respect to any individual over whom the governing body has jurisdiction:
 - (A) To receive information concerning the individual's alleged misconduct; and
 - (B) To discuss, before a determination, the individual's status as an employee, a student, or an independent contractor who is: a physician; or a school bus driver.
- 7. For discussion of records classified as confidential by state or federal statute.
- 8. To discuss before a placement decision an individual student's abilities, past performance, behavior, and needs.
- 9. To discuss the job performance evaluation of individual employees.
- 10. When considering the appointment of a public official, to do the following:
 - (A) Develop a list of prospective appointees.
 - (B) Consider applications.
 - (C) Make one (1) initial exclusion of prospective appointees from further consideration.
- 11. To train school board members with an outside consultant about the performance of the role of the members as public officials.
- 12. To prepare or score examinations used in issuing licenses, certificates, permits, or registrations under IC 25.

- ___ 13. To discuss information and intelligence intended to prevent, mitigate, or respond to the threat of terrorism.
- ___ 14. To train members of a board of aviation commissioners.
- ___ 15. For discussion by the governing body of a state educational institution of assessment or negotiation of the establishment of a collaborative relationship or venture.
- ___ 16. To discuss either of the following:
 - (A) Employee health care options with respect to special exceptions for coverage.
 - (B) Employee handbook changes.
- ___ 17. To review negotiations on the performance of publicly bid contracts when public knowledge regarding the review would cause a likelihood of increased costs.
- ___ 18. To discuss soliciting proposals for the purpose of awarding contracts for goods or services, when:
 - (A) proprietary data, trade secrets, or other information is contained in the bidder's proposal relating to the bidder's unique methods of: (i) conducting business; or (ii) determining prices or premium rates to be charged for services under the terms of the proposal; and
 - (B) public knowledge regarding the discussion would reasonably be expected to result in private loss to the providers of the information described in clause (A).

No other issues or subjects, other than those checked above, will be discussed.
